The InterQual and Milliman criteria offer additional advice to support inpatient admission for pneumonia, including failure of effective outpatient treatment at 24 to 48 hours, respiratory rate greater than 30 breaths per minute, involvement of two or more lobes, and pulse oximetry on room air of less than 89%.

Charting Guidelines IM and PO medications without documentation of strong severity of illness does not meet criteria for continued stay. A patient admitted on Friday or Saturday must meet "severity of illness" and "intensity of service" and have supporting documentation for the entire weekend to be determined "medically necessary."

InterQual published its first severity of illness/intensity of service criteria in 1978 for evaluating appropriateness of admissions and level of service. Later, the company added discharge screens when it realized that hospitals also needed guidance in determining when patients were well enough to go home.
